

SHOOTER/PARTICIPANT RELEASE OF LIABILITY

CLAY TARGET PARTICIPANT AT WAGON WHEEL SPORTING CLUB 4114 Gun Club Rd, Box Springs, GA 31801

Release from Liability- Clay Target Range and all facilities including lakes and grounds.

I, the undersigned am participating in a clay target shooting sport at Wagon Wheel Sporting Club in Box Springs, Georgia. In consideration of the signatures provided below by me and being allowed to participate in the above-described activity, and in full recognition of my ability to safely participate. I hereby release and hold harmless all parties including those in association with Twin Lakes Sporting Club, LLC, dba Wagon Wheel Sporting Club (WWSC). Whether consisting of omission or commission, whether separately or concurrently with someone else, and sustained by me, or us, my spouse, child or children, in connection, directly or indirectly, with the above-described activity. This release is a binding document. This release will also apply to any and all future involvement at the Wagon Wheel Sporting Club.

THE FOLLOWING RULES MUST BE OBSERVED TO INSURE THE SAFETY OF EACH PARTICIPANT AS WELL AS CLUB RANGE PERSONNEL:

- **Protective shooting glasses and ear protection must be worn at all times by all shooters as well as all personnel when on the fields/ranges. Eye and ear protection is mandatory with no exceptions.**
- **The largest shot size allowed is # 7 ½ lead shot or equivalent steel shot.** Shell length is limited to 2 ¾ inches in length. Shot weight is limited by gauge as follows: 12 gauge limited to 1 1/8 oz, 20 gauge limited to 7/8 oz, 28 gauge limited to ¾ oz, and .410 is limited to ½ oz. Magnum loads are not allowed.
- **A shooter may only load his or her firearm when safely within the designated shooting station and only when preparing to shoot.** At all other times, shotguns must be carried unloaded and with the action open. Over-and-Under and Side-by-Side shotguns may be closed after verification of empty chambers and may then be placed in a vertical gun rack.
- **At no time will a shooter load more than two shot shells in a shotgun.**
- **Upon completing a course of fire and before stepping off of the station, all shooter are required to unload their firearm and open the action so that all may view the weapon as empty.** All shooters are responsible for muzzle discipline and for keeping firearms pointed in a safe direction.
- **Practice swings behind any stand are not allowed.** A shooter in the shooting station is required to maintain proper muzzle control.
- **NO ALCOHOLIC BEVERAGES ARE ALLOWED ON PREMISES BEFORE OR AFTER SHOOTING. ILLEGAL DRUGS ARE NOT ALLOWED ON PREMISES. Individuals observed to be under the influence of drugs or alcohol will be escorted off of the property by management or by law enforcement.**
- It is strictly forbidden to shoot any live animal, bird or aquatic life on any field or shooting course.
- Only authorized personnel are allowed in Skeet and Trap Houses or in close proximity to Sporting Clay Trap Machines. All shooters must be accompanied by a trapper/referee unless otherwise specially permitted by authorized personnel.
- Non- participants except trapper and scorers must remain behind all roped off or designated spectator areas.
- All youth shooters, age 17 and under must be accompanied by an adult 18 years or older. This may include adult family members or a certified coach or other range authorized personnel when shooting.
- Wagon Wheel Sporting Club reserves the right to ask any unsafe shooters to leave the premises without refund of target fees if a shooter is observed violating gun club rules or generally accepted NSSA, NSCA or NRA Gun Safety Rules. This is at the sole discretion of the management.

I HAVE CAREFULLY READ AND UNDERSTAND THE ABOVE RULES AND ACKNOWLEDGE THAT I AM LEGALLY BOUND BY THEM FOR MY OWN CONDUCT AND SAFETY WHILE ON THE RANGE PREMISES. I ALSO UNDERSTAND THE INHERENT RISKS INVOLVED IN RECREATIONAL SHOTGUN SPORTS ACTIVITIES BOTH AS A PARTICIPANT AND AS A SPECTATOR.
